The different types of equipment involved and any necessary isolations can now all be clearly identified. The client can configure different personnel to issue permits and extend them as required.

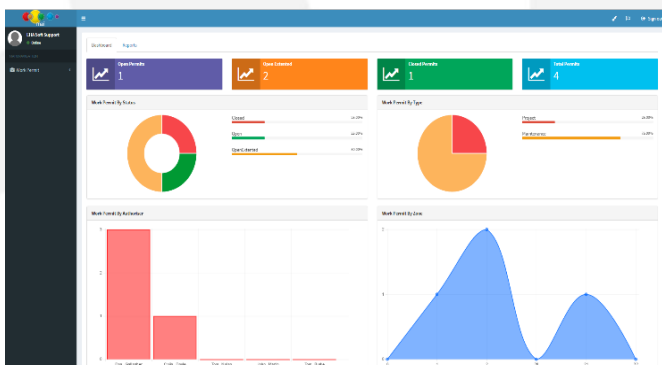
Data collected from AMEREX Integrated mesh network can now be transported via one network to control work permits in the work place. Using AMEREX Integrated Work Permit along with the Contractor Portal gives the end user peace of mind, in the knowledge that their facility is

The Contractor Portal empowers the contractors and forces them to provide correct information to be compliant with the facility's standards.

Server Requirements

- Processor: 32 Bit/64 Bit. Intel i3 or higher.
- RAM: 4 GB or Higher (8 GB recommended).
- Hard Disk 80 GB or above
- Network: 100 Mbps Server Network Adapter
- Operating System: Windows Server 2008 sp2 32 Bit/64 Bit or higher. (IIS Server should be IIS 7)
- Third Party Software: Microsoft SQL Server 2012 Enterprise Edition. Microsoft Net Framework 4.5.5 or Later.
- In order to run the application, browsers that support HTML 5 should be used with JavaScript enabled. Google chrome, Firefox (recent version), Internet Explorer (IE 8 and above) etc. can be used.
